- Kirklees Council was in a state of flux due to the lack of a council leader, therefore the CE was currently running the council.
- The Children's Service issue was raised, as this may go into special measures.
- Cllr Dodds had been elected Mayor 2 weeks ago and wished to speak to the council about his chosen charity, the Royal British Legion. He had had calendars made up in honour of all those who gave their lives in service, in particular the six service personal killed recently in Afghanistan.
